



DIAMONDS ACADEMY RULES

§ 1

GENERAL PROVISIONS

- 1. Those are the rules of Diamonds Academy (hereinafter referred to as **Rules**) that regulate the principles of functioning and participation in Soccer School **Diamonds Academy** (hereinafter referred to as **Club**).
- 2. Soccer trainings in Diamonds Academy are organized by **Diamonds Academy Sports Club** (Klub Sportowy Akademia Piłkarska Diamonds Academy).
- 3. Only girls may participate in the trainings carried out by Diamonds Academy.
- 4. In order to become a member of a Club one has to deliver filled out **Declaration of membership.**
- 5. Number of participants in a training group is limited.
- 6. Joining **the Club** is presided by the player's and parents' agreement to obey the Rules of the Diamonds Academy.
- 7. Parents/Guardians acknowledge and consent to photographs and electronic images being taken of their child during her participation in any soccer activities. They acknowledge and agree that such photographs and electronic images are owned by Diamonds Academy and that the Diamonds Academy may use the photographs for promotional or other purposes without their further consent being necessary.
- 8. Parents/Guardians become Supporting members of the Club through signing the Declaration of Supporting Member of Association. They obliged to obey Diamonds Academy Rules and declare that they will support support the activities of the Association by paying the monthly fee (Article 2, p.1).

PAYMENTS AND CONDITIONS OF PARTICIPATION

- 1. Monthly tuition fee (hereinafter referred to as **tuition fee**) is paid by transfer to the Club's bank account (47 1750 0012 0000 0000 3108 6302) paid with the transfer title "**Training venue. Name and Surname of the child + name of the month**". The fee is paid in advance on the 10th day of every month and it covers the costs of the trainings carried out in certain month (hiring pitches, training facilities and coaching staff). Amount of tuition fee depends on the player's training group:
- U8, U10, U12, U13, U16 trainings two times a week, monthly fee in the amount of **PLN 170** (one hundred seventy zlotys)
- -Lil Diamonds U6 training once a week, monthly fee in the amount of **PLN 120** (one hundred twenty zlotys)

Parents of the player who is a student of Elementary School in American School of Warsaw are exempted from monthly fees.

New members of the club pay the entry fee in the amount of **PLN 170** (one hundred seventy złotys)(hereinafter referred to as "**Entry fee**"), paid by transfer to the Club's bank account (47 1750 0012 0000 0000 3108 6302, transfer title: "**Training venue. Name and Surname of the child + entry fee**") non-later than 5 days from signing the **Declaration of membership.** Paying the entry fee is necessary to become a member of the Club.

- 2. Within the entry fee the Club provides the players with the Club's kit match sports kit (jersey, shorts and socks, Adidas) and training sports kit (jersey, shorts).
- 3. The entry fee is not refundable.
- 4. Parents/ Legal Guardians and the Player may **resign from Club's membership** uder the condition of submitting a statement on resignation from trainings one full month before beginning of a new calendar month.
- 5. A written statement is needed in order to resign from Club's membership. The statement may be sent via email to: info@diamondsacademy.pl.

- 6. Resigning from Club's membership after the date referred to in point 4 does not release from monthly fee and does not entitle to seek **reimbursement from the Club** for the fees paid for a certain month regardless from the given reasons.
- 7. Participation in the trainings is voluntary. Player's absence in trainings does not exempt the Player/Parent/Legal Guardian from monthly fees.
- 8. The Club has a right to cancel a training session under special circumstances. The cancelled training will be made up in a date given by the Club.
- 9. Trainings are not carried out on holidays and statutory holidays.

§3

ORGANIZATION OF SOCCER TRAININGS

1. The Club ensures that:

- a) every training group has maximum 20 players;
- b) every training group is led by at least one licensed Coach;
- c) trainings are carried out according to Diamonds Academy own training program prepared especially for girls;
- d) every Player will be provided with the Club's kit match sports kit (jersey, shorts and socks, Adidas) and training sports kit (jersey, shorts). Cost of the kits is covered by entrry fee.
- e) every training venue has a professional sports equipment.
- 2. Parent/Legal Guardian is obliged to inform the Coach about possible health contraindications to Physical Activities of the Player, that may endanger Player's health or life, before the a trial training of the Player.
- 3. Parents or Legal Guardians are obliged to inform the Organizers about any diseases, injuries or other disorders that prevent the child to safe participate in sports.
- 4. Parents/ Legal Guardians is **obliged to do comprehensive medical examination** that indicates no contradiction to Physical Activity performed by a Player. The examination results should be delivered to the Club in two months from the time of joining the Club.

- 5. Parents/Legal Guardians **bear liability for the damages caused** by the Player under the provisions of the Civil Code.
- 6. Parent/ Legal Guardian releases the Club and all of its employees from all liability, responsibility, costs and damages that may arise from the player in their care participating in the Training Sessions, Matches, Physical Tests.
- 7. The Club is not liable for loose of Player's personal items left by the Players.

§ 4

PROCESSING OF PERSONAL DATA

- 1. By accepting Diamonds Academy Rules Parents/Legal Guardians agree to the processing of Parents/Legal guardians and Player's personal data included in the declaration of membership for the marketing purposes of Diamonds Academy with the registered office at Dywizjonu 303 127/91 Street, 01-470 Warszawa (according to the Law of Personal Data Protection from 29 August 1997, Dziennik Ustaw No.133, item 883).
- 2. **Personal data** of Players/Parents/Legal are processed by the Club (Klub Sportowy Diamonds Diamonds Academy with the registered office at Dywizjonu 303 127/91 Street, 01-470 Warszawa) only in the aim that is necessary to organization and caring out trainings.
- 3. The Club will store/process Players'/Parents'/Guardians' personal data **according to the provisions of the law.** The Club will use technical and organizational security measures in order to protect Players'/Parents'/Legal Guardians' personal data that it administer from manipulation, loss and destruction, as well as from third-party access.
- 4. The Club will not disclose Players'/Parents'/Legal Guardians' personal data to third parties, nor market it in another way.
- 5. Parents/Legal Guardians will be able to access the information through the Club or change it.
- 6. Parent/Legal guardian commits to inform about the changes of data presented above in the term of 7 days from change occurrence.

- 1. In the matters not regulated herein the provisions of the Civil Code apply.
- 2. Not obeying the rules or a flagrant violation of the Rules may be the reason to expell the Player from the Club.
- 3. The Club has a right to change Diamonds Academy Rules with advance notice of Parents/Legal Guardians.
